## Shree Minerals Nelson Bay River mine opening

The company today celebrated the transformation of the company from a junior explorer to an iron ore producer with the opening of the Nelson Bay River project (NBR).

Some of the key points of Mr Loyalka address:

- We discovered DSO Iron Ore very early in our exploration campaign in 2010, thanks to the foresight of one of the most accomplished Geological minds in our very own Mahendra Pal.
- The company took an enterprising approach of diving straight into the project development mode even while the resource was being defined & requisite feasibility studies being carried out. This was instead of adopting the sequential approach usually followed in the industry.
- We focused on preserving our capital & cash resources .
- This meant the exploration potential was preserved as we have only just scratched the surface from a resource exploration viewpoint.
- We engaged in environmental baseline studies & the approval process in mid 2010, such that necessary applications for approvals could be made early in 2011.
- The company committed itself to best practice environmental management commitments, which sets new standards in the industry.
- Through these pragmatic actions, we have successfully brought the NBR project to this stage.

In 2012, the Company announced it's first Maiden Reserves along with the mine plan for the first couple of years of DSO operation. Requisite studies have been completed for the DSO phase to a bankable feasibility level. This confirms that the NBR project can deliver returns to shareholders and benefits to a range of stakeholders, particularly those in the NorthWest Tasmania. Additionally, the Company has announced the results of a Pre Feasibility Study (PFS) involving all stages of the project. The PFS delivered robust results, confirming the long-term value potential of the NBR project over a mine life of ten years.

Mr Loyalka said the implementation of best social and environmental practices, well beyond simple compliance, has been an integral part of the Company's philosophy. The company continues to pursue Best Practice Environmental Management . The development of the NBR project has being undertaken with an innate sense of responsibility towards the well-being of the society and the environment.
